CF24. APOLOGIES

Apologies for absence from the meeting were received from Councillors G Bellamy, C Bolton, S Butler, P Crooke and M Oliver (all personal).

CF25. DECLARATION OF INTERESTS

Councillor K Gulson declared a disclosable pecuniary interest in item CF29 by virtue of being a Council allotment holder.

CF26. MINUTES

Councillor K Gulson proposed approval of the Minutes of the Committee held on 28th June 2016. This was seconded by Councillor J Willis and unanimously **RESOLVED**.

CF28. REVIEW OF FEES AND CHARGES

By way a report by the Clerk (a copy of which is appended in the Minute Book) Members reviewed the fees and charges for the cemetery. Having been advised of the rates charged by neighbouring authorities, it was proposed by Councillor R Butcher that with effect from 1st September 2016 the fees and charges for the Cemetery be as follows:

CF29. ALLOTMENTS

Further to Minute No.CF18, Members were advised that the Working Group had looked at the pond area in the Recreation Ground as an alternative venue for allotments. Following this visit an allotment holder on Bellvue had visited the office and commented that they didn't want to move. With this in mind, a meeting between the Working Group and the Bellvue allotment holders has been arranged to discuss the future of this site.

Whilst discussing possible usage of the pond area in the recreation ground a suggestion was made that a small area be given to the infants school to develop an allotment garden. Another idea was creating an area for use by the Green Back Yard Project with possible raised beds. Both ideas would be pursued further.

CF30. FIELD ON CHURCH STREET/WATERSLADE ROAD

By way of a report by the Clerk (a copy of which is appended in the Minute Book) Members were advised that the former tenant had returned the field to the Parish Council and a decision was required on the way forward.

Having noted the contents of a draft licence for the field, it was proposed by Councillor A Wood that bids for the field's licence be invited from interested parties and the Clerk be authorised to enter into a licence with the successful applicant. This was seconded by Councillor R Butcher and **RESOLVED** unanimously.
